SCOPE OF POSITION:

The District Supervisor will oversee all day-to-day activities for the water and wastewater Operators in the Orangeville District. The District Supervisor will provide support to the Director, Operations on all related initiatives and will support the various Account Managers on sales and growth opportunities.

The District Supervisor plans, leads, and coordinates the delivery of Operations and Maintenance (O&M) services for decentralized water and wastewater systems that range from Water Distribution and Supply, to Class II MBR Wastewater Treatment, to industrial Wastewater Treatment using Membrane Ultrafiltration and Reverse Osmosis. The Supervisor will support cohesion within the team, while ensuring operational effectiveness, seek out efficiencies, optimize the lifecycle of the assets using best practices for maintenance activities, and promote a safe workplace.
