#### 1.0 PURPOSE

The Membership Services Committee's purpose is to ensure value for members as evidenced in retention and attraction. This is achieved through member outreach & connection, sourcing of valuable membership benefits, the development & implementation of member focused programs, and reviewing the membership categories & annual rates.

#### 2.0 RESPONSIBILITY

Membership is governed by section 9 of Bylaw No. 1. There are three classes of members in the association.

- Voting Member
- Student Member
- Honorary Member

All members are eligible to access member rights, benefits, services, products and discounts available from the association for their membership category (additional criteria and/or fees may apply). The rules regarding fees, levels, rights, benefits and services are found in the OOWA By-Laws document.

#### 3.0 MEMBERSHIP

Membership in OOWA shall be open to all persons with an interest in the onsite and decentralized wastewater industry and a desire to fulfill OOWA's mission, vision, and goals. Membership in OOWA is obtained by completing a membership application and paying the appropriate annual fees. Membership fees are outlined in the membership fee schedule (Appendix A).

#### 3.1 VOTING MEMBERS

#### 3.1.1 Individual Member

An individual, either on their own or part of an organization.

Organizations may apply for Individual Memberships for multiple persons in accordance with the Multi-Member Fees schedule (Appendix A). One person of the applicant organization will be identified as the Anchor Individual Member for that organization. Renewal dates of the Individual Members of that same organization occur on the same date.

#### 3.1.2 Associate Member



Members of organizations that perform notable public or private activities directly or indirectly in the onsite and decentralized wastewater industry may register as Associate Members. The organizations recognized by OOWA to whom an Associate Membership is extended are listed in Appendix B

#### 3.1.3 Young Professional Members

An individual who provides proof of age, 30 years or younger, at the time of application or renewal of membership.

#### 3.2 STUDENT MEMBERS

An individual student member must be enrolled in an accredited post-secondary academic institution full time to receive his/her complimentary OOWA membership. Proof of enrolment must be submitted annually.

#### 3.3 HONORARY MEMBERS

#### 3.3.1 Appointed

An individual, not professionally engaged in OOWA, who performs or has performed notable public or private service for the development or education in the onsite and decentralized wastewater industry. This status shall require a unanimous vote by the Board of Directors. The yearly membership fee is waived for an Appointed Honorary member.

#### 3.3.2 Reciprocal

OOWA partners with like organizations advocating for the onsite wastewater industry in Canada in the form of Reciprocal Memberships. These connections between associations help open the channels of communication to exchange information, ideas, and experiences. Complimentary memberships provide an opportunity to keep industry players abreast of what is going on in their respective provinces.

#### 3.3.3 Lifetime

Members with demonstrated dedication to both OOWA and the onsite industry may be awarded a lifetime member designation. Nominations may be submitted by active members. This designation requires a unanimous vote by the Board of Directors and the yearly membership fee will be waived. The suggested criteria for such a designation is as follows:



- Person must be retired from the industry
- A minimum of 10 years of paid membership in OOWA
- o A minimum of five years participation in either the OOWA BOD or a committee
- The person must be considered to be a good industry and association ambassador

### 4.0 MEMBER IN GOOD STANDING


A member in good standing is a person whose fees are current. Members who do not pay their fees by the cut-off date will lose their membership status with all its rights and privileges. Members who have lost their membership status may become a member in good standing upon payment of all outstanding debts due to OOWA.

#### 4.1 DIRECTORY

- 4.1.1 OOWA will maintain an on-line database of its membership. Only names of Members in Good Standing will be published on the OOWA website.
- 4.1.2 It is the responsibility of OOWA to ensure the protection and archive of the membership database. Accuracy of the information is the responsibility of the members themselves.
- 4.1.3 The Ontario Onsite Wastewater Association respects the privacy of all our members. Information collected and displayed on OOWA's Membership Directory may be shared with membership benefit providers in order to procure and sustain new and existing partnerships. This information will not be used for the purposes of third-party solicitation and one can opt out of information sharing to benefit providers by checking the opt out box on the application, or within your online membership profile.

#### 4.2 TERMINATION OF MEMBERSHIP

- 4.2.1 The Board of Directors, upon the recommendation of the Membership Committee, reserves the right to terminate membership in the association. Grounds for termination would include the following:
- 1. A failure to pay the annual membership fee. A member will be given 60 days grace before membership is terminated.
- 2. Actions or statements that are contrary to the provisions of the association's Code of Conduct, Bylaws, its mission, vision, goals and core values statements.
- Actions or statements which are detrimental to the wellbeing of the association and the membership.





4.2.2 Prior to the recommendation for termination, the Membership Committee will have made every effort to contact the member involved to attempt to clarify and rectify the issues that have led to the consideration of the termination of membership.

#### 4.3 APPEALS

4.3.1 If a member or a prospective member disagrees with the actions of the Membership Committee, either in relation to the acceptance or rejection of a membership application or to the termination of a membership, that member or prospective member may appeal the committee's decision to a panel consisting of the Chair of the Membership Committee, the President, and one other member of the Board of Directors. The decision of this panel will be final.


### 5.0 REFUNDS & TRANSFER OF MEMBERSHIP

Annual membership dues are non-refundable.. Transfers of membership can be reviewed by the membership committee, upon request. It is the responsibility of the member and/or the organization to notify OOWA of any change in membership status.

Definition/Acronym	Description
Ontario Onsite Wastewater Association (OOWA)	Also operating under the name of Ontario On-site Wastewater Association.
OOWA Board of Directors	A body of elected or appointed members who jointly oversee the activities of OOWA.
Membership Committee	An operating committee of the OOWA Board of Directors charged with oversight of association membership. Committee members are drawn from members of the association's membership including one Director, with a Chairperson selected from among the committee members.
Leadership	President, Vice President, Treasurer, and Secretary.




